Enchanted Closet Volunteer and Board Service Descriptions

Volunteers may donate their talent and time to single activities or may regularly contribute to ongoing programs planned and implemented by the Youth Empowerment Board. Volunteers may also serve as advisors, coordinators, facilitators, and mentors. Volunteers must complete mandatory training and successfully perform volunteer duties at established times and places. Enchanted Closet reserves the right to terminate any volunteer not meeting the organization's needs.

Youth Empowerment Board is the advisory and program planning board of the Enchanted Closet. Youth Empowerment Board members may serve as advisors, coordinators, facilitators, and mentors. The Youth Empowerment Board consist of committees that coordinate programs and events such as the annual Prom Dress Giveaway and the GIRL\$ Programs. These committees are:

- Communications and Public Relations
- Dress Drive Coordination
- Hospitality
- Program Development
- Boutique Operations and Business Development
- Special Events
- Charitable Gifts/Sponsorships
- Student Outreach
- Volunteer Coordination

Commitment: Youth Empowerment Board members must be able to meet monthly and volunteer 8-12 times between January-December. However, board members may serve in an advisory and resource capacity only and may commit to provide resources that reduce the operational expenses of the organization instead of giving time. Volunteer times are flexible based on the position and tasks identified with each member. Youth Empowerment Board members must donate or raise \$100. Consideration will be given for donations secured that reduce the operational expenses of the organization. Members must complete mandatory training.

The Board of Directors (BOD) of the Enchanted Closet, Inc., a non-profit organization, is responsible for prudently governing the organization in regards to financial matters and strategic planning. Directors ensure that all actions further the mission of the organization. Directors serve on the Board on a volunteer basis. Prior board experience or training is a plus.

Commitment: BOD members must be able to meet monthly, attend events, and donate or raise \$500. Board members may serve in an advisory and resource capacity only and may commit to provide resources that reduce the operational expenses of the organization instead of giving time. Members must complete mandatory training.
